We have never had this many children! Most of them are much too little to know what their mothers are going through.

As I write this, the stock market looks like Mr. Toad's Wild Ride, people are losing their jobs and their homes and calls for help are everywhere. Perhaps God is just reminding us on whom we should really depend.

We are sending you this letter because you have cared for and supported Alpha House in the past. You know that we are the only licensed maternity home in Hillsborough County and that we've been serving pregnant women in crisis since 1981. As we wait for the market to settle down and the economy to recover, mothers and babies continue to come to us for safety and comfort. So far this year, 116 expectant mothers in crisis have relied on us because they had nowhere else to turn. Right now, we have 39 moms and 33 babies and children that call Alpha House their home. *

As these families in crisis turn to us, we are turning to you. Running a household of this size is a challenge. Safety, hope, counseling, case management, parenting and life skills classes and spiritual support help our women deliver healthy, normal birth weight infants and begin their journey to the promising lives intended by our mission. We are rapidly approaching the end of the year – a very difficult year. Would you consider a gift at this time? It could mean the difference between hope and despair for a young woman and her infant.
